Abstract: The Ministry of Energy, Transport and Telecommunications (the "Ministry") invites expressions of interest from eligible and qualified bidders for the supply, delivery and maintenance of 150 School Buses (the "Goods") to be used specifically for the transportation of school children across Jamaica.

Background: The implementation of a National School Transportation System (NSTS) is a priority programme of the Government aimed at ensuring the provision of a safe, efficient and affordable mode of transportation for students across Jamaica. For years, the Government has been grappling with the issue of getting children to school safely and in an efficient, timely and affordable manner. This has become more poignant with the number of accidents claiming the lives of or seriously injuring many students, the increase in abuse of students on the mostly unregulated public transportation and their disappearance resulting from the lateness of the time they are out and the source of transportation they are forced to utilize. The shortage of adequate transportation has also resulted in overloading of the available transport, extremely long waiting times, and tremendous inconvenience for these students.

The provision of the NSTS will ensure that an adequate number of buses are available to meet the demands of students across Jamaica and, in so doing, enhance the efficiency, reliability, and overall user experience of the school bus transportation system.

Request for Expression of Interest (REOI): The Ministry of Energy, Transport

and Telecommunications now invites eligible Suppliers to indicate their interest in providing and maintaining the School Buses. Interested Suppliers should provide information demonstrating that they have the required authorization, capacity and capability to supply, deliver and provide maintenance services for 150 School Buses. For the avoidance of doubt, a School Bus for the purpose of this procurement, is a large, specialized/specially designed motor vehicle, often yellow, designed and equipped with safety features, like flashing lights and stop signal arms, to transport children to and from school safely and securely in comfort.

This is an online invitation where documents will only be made available and responses accepted via the Government of Jamaica Electronic Procurement (GOJEP) System (via the url: www.gojep.gov.jm). No offline (hard copies) documents will be accepted.
