CONDITIONS FOR ENTRY

The innovation or invention ideally should:

1. Be in use or its functionality can be practically demonstrated.
2. Perform a function that makes life easier and/or improves the quality of life.
3. Display creativity and demonstrate the economic use of material(s) available locally or indigenous to Jamaica.
4. Be the creation of an original, or a unique adaptation of existing gadgets, equipment, concepts, processes, products, or services with social or economic benefit
5. Have realized or have potential for commercialization.
6. Be safe for use and environmentally friendly.
7. Must **NOT** infringe on any intellectual property rights or legal statutes.

All submissions will be judged according to the conditions of entry and specific criteria for each category. Entry Forms are the property of the organisers and the judges' decisions are final.

Entrants must have consultation with the Jamaica Intellectual Property Office (JIPO) before submitting applications (forms must bear the JIPO stamp).

The competition is open to members of the public as well as Public and Private Sector organizations in Jamaica.
